May I begin by welcome you all to Bangkok and sincerely thank the organizer for giving me this opportunity to deliver a remark at the opening session of the international conference. This conference is a major pre-congress satellite meeting of the 19th International Congress of Nutrition. It just happens that I have been entrusted by the Nutrition Association of Thailand to be the Chairman of the Organizing Committee and the President of the congress. I do believe that you will be able to participate in the nutrition congress to share and learn more about nutrition. As a matter of fact, nutrition is a link between food and health in fulfilling of nutrient and non-nutrient requirement from food. Quality of food composition data- key for health and trade, the theme of this conference is indeed very crucial and timely.

In the current society, we are witness the rising trend of ageing population, globalization, urbanization, changing in lifestyle and eating habits. Nutritional challenges have also been shifting from under nutrition to over weight, obesity and diet related chronic diseases. Nutrition information of food products is often required to be provided. This can hardly be achieved without food composition information that is accurate, up-to-date and utilizable.

In 1983 when Thailand organized the 4th Asian Congress on Nutrition, Professor Aree Valyasevi was the Chairman of the Organizing Committee and I was the Secretary General of that Congress. The INFOODS was first introduced to Asian's food and nutritional scientists the very first time by Professor Nevin Scrimshaw, the founder of INFOODS. It was emphasized at that time on the standardization to generate food composition data, to compile food data in a systematic ways to be friendly for users, and to promote for widely utilization. Apparently, this concept is still quite valid today.

I would like to extend my sincere appreciation and congratulation to the Organizers of this conference for their hard work in the preparation of this event. I am certain that the conference will provide a good opportunity for scientists from all regions of the world to share their knowledge and experience with the common goal to improve food composition data. Finally, I wish you a fruitful and successful conference and hope that you will participate in the 19th ICN. Please also spend some time to enjoy Thai food and cultures.
